Art. 5 SHARE CAPITAL

The share capital of the company is 25.044,849 lei, subscribed and fully paid, cash contribution, taken over from the divided company Turism Hoteluri Restaurante Marea Neagra SA and is divided into 250.448,490 shares with a nominal value of 0,10 lei each. The company's shares are registered shares in dematerialized form.

Art. 7 CHANGES IN SHARE CAPITAL

The share capital can be increased by:

- the issue of new shares;

- increasing the nominal value of existing shares.

The increase of the share capital may also be made by contribution in kind, in compliance with the legal conditions.

Share capital can be reduced by:

- reduction in the number of shares;

- reduction of the nominal value of the shares;

- the acquisition of own shares, followed by their cancellation.

Share capital can also be reduced, when the reduction is not motivated by losses, by:

- total or partial exemption of the shareholders from the payment of the due instalments;

- the return to the shareholders of a part of the contributions, proportional to the capital reduction and calculated equally for each share;

- other procedures provided by law.

The shares issued by increasing the share capital shall be offered for subscription first to the other shareholders, in proportion to the number of shares they hold and with the obligation that they exercise their preference rights within the term decided by the general meeting of shareholders.

Art. 8 ACTIONS

The total subscribed share capital is divided into 250.448.490 registered shares in dematerialized form, with a value of 0,10 lei each, being divided as follows by shareholders:

1) TRANSILVANIA INVESTMENTS ALLIANCE S.A. BRASOV owns 226.942.936 shares;

2) MAMAIA NORTH INVESTMENTS S.A holds a total of 21.040.000 shares.

3) CONSULTING & CONSTRUCTION INVESTMENTS S.A. holds a total of 2.465.554 shares;

All shares issued by the company are registered, dematerialised and indivisible.

Each shareholder holds a number of registered shares corresponding to the subscribed share capital.

Shares have equal value and give holders equal rights. The share capital may not be increased and new shares may not be issued until the previous issue has been fully paid up.

The transfer of shares is carried out in accordance with the legal provisions. Every share gives the right to one vote in the general meeting.

Art. 9 MANAGEMENT AND REPRESENTATION OF THE COMPANY

The company is managed by a sole administrator. Administrator of the company is appointed Mr. Rosu Bogdan - Nicolae, Romanian citizen, married, born on 27.11.1980, in Slatina municipality, Olt county, domiciled in Bucharest municipality, Sector 1, 341 Ion Mihalache boulevard, staircase A, 2nd floor, ap. 6, identified with identity card series RX, no. 823073, issued by S.P.C.E.P. Sector 1, on 03.12.2015, valid until 27.11.2025, with personal code 1801127284547.

The term of office of the administrator is 2 years. The administrator has full powers.

The sole administrator may complete and restrict the secondary object of activity, and the modification of the main object of activity can only be done by resolution of the shareholders.

The Administrator appoints the Managing Director, the Administrator may also be the Managing Director with the approval of the AGM.

The Managing Director may decide to hire executive directors. The operations of the company may be carried out by one or more executive directors, who shall be officers of the company and may not be directors.

Art. 10 GENERAL MEETING

The supreme governing body of the company is the general meeting of shareholders of the company.

General meetings are ordinary and extraordinary. They shall be held at the registered office of the company or at the place fixed in the convocation.

The ordinary general meeting of shareholders shall meet at least once a year, not later than five months after the end of the financial year. The powers of the ordinary meeting are those provided for in Article 111 of Law 31/1990 republished. The presence of shareholders representing at least one-fourth of the share capital is necessary for the validity of the deliberations, and the resolutions are taken by a majority of the votes cast.

If the Ordinary General Meeting cannot work due to the non-fulfilment of the conditions provided for in the previous paragraph, the meeting to be convened at a second convocation may deliberate on the items on the agenda of the first meeting, regardless of the quorum present, taking decisions by a majority of the votes cast.

The extraordinary general meeting of shareholders may be convened by the persons provided for by law, whenever situations expressly provided for therein arise (Article 113 of Law 31/1990 republished).

For the validity of the deliberations of the Extraordinary General Meeting of Shareholders, the presence of shareholders holding at least one fourth of the total number of voting rights is required at the first convocation, and at subsequent convocations, the presence of shareholders representing at least one fifth of the total number of voting rights.

Resolutions are passed by a majority of votes held by shareholders present or represented. A decision to change the main object of activity of the company, to reduce or increase the share capital, to change the legal form, to merge, to split up or to dissolve the company shall be taken by a majority of at least two thirds of the voting rights held by the shareholders present or represented.

Shareholders representing the entire share capital may, if none of them objects, hold a general meeting and take any resolution within its competence, without complying with the formalities required by law for its convening.

At general meetings, shareholders may be represented by persons other than those who are shareholders, in accordance with the law.

Each paid share entitles you to one vote. The exercise of voting rights is suspended for shareholders who are not up to date with payments when due.

Decisions shall be taken by open vote, except those concerning the election and revocation of administrators and auditors as well as the responsibility of administrators which shall be taken by secret vote.

Shareholders who do not agree with the resolutions taken by the general meeting concerning the change of the main object of activity, the change of the registered office or the form of the company have the right to withdraw from the company and to obtain the consideration for the shares they hold.

Art. 11 AUDITORS

The company will have three auditors and one alternate auditor. Their term of office is three years and they may be re-elected. The members of the board of auditors are:

The auditors will execute their mandate personally.

The auditors are obliged to supervise the management of the company, to check whether the financial statements are legally drawn up and in accordance with the books, whether the latter are kept regularly and whether the valuation of the assets and liabilities has been made in accordance with the rules established for the preparation and presentation of financial statements. They shall also perform other duties prescribed by law in accordance with the conditions laid down by law.

Art. 12 COMPANY REGISTERS

The company shall keep records of shares and shareholders in a register in which the identification data of the shareholders, the number of shares held and the payments made are mentioned. The company shall keep all the registers provided for in Article 177 of Law 31/1990.

Art. 13 ACCOUNTING EVIDENCE

The company hereby incorporated, as a trader, is legally obliged to organize and conduct its own accounts.

The balance sheet and profit and loss account shall be prepared in accordance with the law.

Art. 14 DURATION OF COMPANY

The company is established for an indefinite period of time, starting from the date of registration in the Trade Register.

Art. 15 BENEFITS AND LOSSES

Profits and losses will be divided among the shareholders of the company in proportion to the participation in the share capital.

Art. 16 FINANCIAL STATEMENT

The financial year begins on January the 1st and ends on December the 31st each year.

For the first year of activity, the financial year begins on the date of registration of the company in the Trade Register, and for the last year, it ends on the date of deregistration from the Trade Register.

Art. 17 AMORTIZATION OF FIXED ASSETS

The administrator of a company shall establish, according to the law, the way of depreciation of fixed assets, in compliance with the legal provisions in force.

Art. 18 INSURERS

The administrator of the company shall order the insurance of goods for which the law provides for their obligation. For goods for which insurance is optional, the administrator of a company shall order for which of them insurance shall be effected.

Art. 19 COMPANY STAFF

Employment contracts to be concluded with employees of the company shall be signed by the administrator of the company or his authorized representative.

Salary, tuition, calculation and payment of salary obligations to the budget, will be established by the administrator or his delegate, in compliance with the legal conditions in this matter.

Art. 20 WINDING UP AND LIQUIDATION OF THE COMPANY

The company will be dissolved in the following cases:

Any amendment to the articles of incorporation shall be made under the conditions and in accordance with the legal procedure. In fulfilling their obligations, the shareholders of the company shall act in good faith.
