In the context of declared coronavirus pandemia by the World Health Organisation, we consider that the cash flow of our firm may be affected by this situation.

We mention the fact that our firm has ongoing investments at active assets of the firm patrimony, according to Investment Budget approved by AGOA Decision nr.19/19.12.2019.Main source of the investment program is amortisation, source that will be realised in the third trimester of 2020.

Also, considering the specificity of activity, realisation of incomes predominantly in the third trimester, financial resources availability are required in order to cover the necessary finance for the material base.

In consideration of the above mentioned, we appreciate that it would be necessary to extent the credit line contracted with BCR. We mention that not using the credit line does not generate suplimentary costs to affect the Budget aproved for 2020.
