As can be seen in the table above, only the EBIDTA Margin indicator (50.95%) was achieved, both in terms of the BVC (29.63%) and the minimum value approved in the GMS (23 %), the indicators Gross operating profit and Occupancy rate being strongly affected by the spread of the SARS-CoV-2 coronavirus, which had the effect of delaying the opening of hotel units.
